#### REPORT OF THE FIRST SESSION OF THE EIGHTEENTH TRIENNIAL SYNOD

## HELD AT BRIDGES EVENT CENTRE, GIFFORD HILL ON FRIDAY AND SATURDAY 14<sup>TH</sup> AND 15<sup>TH</sup> MAY 2021

#### COMMENCEMENT

The Synod assembled at the Bridges Event Centre (Macquarie and Legends Rooms), Gifford Hill at 1:00pm Friday 14<sup>th</sup> May.

The Right Reverend Keith Dalby welcomed Synod members to the Bridges Event Centre and his first Synod as President. Housekeeping matters were addressed.

The President presided with 20 clerical and 48 lay members of Synod in attendance.

#### **MEMBERSHIP**

- (a) what do we as a Diocese want to achieve by such amendments,
- (b) what kind of church do we want to be,
- (c) what kind of priests do we want and
- (d) what sort of structure do we want,

determines not to consider, at this Session of Synod, any such Measure as may be listed on the Notice Paper.

Vote by voice initially, then by show of hands.

That this Synod notes that charges of theft, laid against the late Reverend Dr Peter Carlsson in February 2019, for allegedly removing items from the Cathedral at Murray Bridge, were withdrawn by the prosecution on 27<sup>th</sup> May 2019 and dismissed by a Magistrate pursuant to Section 72 of the Criminal Procedure Act and apologises posthumously to the late Reverend Dr Peter and his family for the extreme pain and suffering caused to him as a result of the laying of these charges.
