#### MINUTES OF THE FIRST ANNUAL SESSION OF THE NINETEENTH TRIENNIAL SYNOD

# HELD AT CHRIST CHURCH, MOUNT GAMBIER ON FRIDAY 21, SATURDAY 22 AND SUNDAY 23 JUNE 2024

#### **FRIDAY 21 JUNE 2024**

The Synod commenced on Friday afternoon at 4:00 p.m. with the Synod Eucharist presided over by the Diocesan Administrator, Br Simon Waters, the sermon delivered by the Ven David McDougall. Following the Eucharist Synod Members adjourned to the Parish Hall for the Administrator's Presidential Address, at the conclusion of which Synod adjourned until Saturday morning.

## **SATURDAY 22 JUNE 2024**

At 8:50 a.m. Synod opened with Prayer. Matters of housekeeping were dealt with and a welcome from the Parish of Mount Gambier followed. The ac.care Acknowledgement of Country video was played.

Anglican Community Care – Mr Rick Fisher (Chair), Trish (Community Centre Manager). Rick Fisher spoke of the origins of ac.care in the Christ Church Parish Hall (Mount Gambier). Trish, the Community Centre Manager in Mount Gambier, described the daily routine of the Centre.

**Safe Ministry** – Tara McCracken, Mount Gambier Parish. Spoke about the importance of the Safe Ministry process.

**Anglicare SA** – Jack Monaghan, Community Engagement Worker. As well as speaking about his role in linking with parishes he reminded the Synod that Anglicare SA provides seed funding for approved community projects.

**Archdeacon responsible for Diocesan Youth and Children Activities** – The Ven Neil Fernando. It is important to have activities which engage children when they are present.

**Tertiaries of the Society of St. Francis** – Jeannie Minnis, Regional Minister of TSSF. Spoke about the Tertiaries as a lay group who continue to be inspired by St. Francis of Assisi while living life in the community and invited anyone interested to contact her.

Jeannie also expressed thanks for support for the 'Socks and Jocks' campaign to provide items for the Drug and Alcohol Detox Unit, Glen Osmond, Adelaide.
