#### ADJUSTMENT OF DATES FOR SAFE MINISTRY TRAINING DURING 2019

It has become necessary to adjust some of the dates for the Safe Ministry Training within the Diocese for 2019. Please replace any notices on notice boards with this new circular and make the information widely known throughout your church communities. All other details provided in the circular dated 10<sup>th</sup> May 2019 remain the same.

The Safe Ministry Training is required for anyone who holds a licence as a Bishop, Priest or Deacon, or is a Lay Minister holding the Bishop's Licence to Preach, ministering communion while robed, involved in the leadership of worship, involved in children's and youth ministry, ministering to the elderly and vulnerable, an official hospital or home visitor, all choir directors, a churchwarden or a paid op shop manager.

Full day training is available to those who hold the above mentioned positions and **who have not as yet** completed a Safe Ministry Training session offered by the Diocese via the National Council of Churches Australia. The Full Day training is also recommended for those who have not attended any Safe Ministry courses for more than four years. Refresher courses are available to those for whom it is has been three years since they last attended the training.

The Child Safe Environments Course was introduced across the Diocese as one of the recommendations of the Royal Commission into child sexual abuse. This course supplements the Safe Ministry course and is mandatory for all clergy, all key leaders in the Diocese and anyone who has contact with children and vulnerable people. This includes Ministry Leaders of Sunday Schools, Youth Groups, Pastoral Carers and hospital or home visitors and those involved in a crèche, childcare or a playgroup, paid Op-shop managers or at least one key person involved in operating each Op-shop in the Diocese.

If you have already done this course within the last three to four years, in the Diocese of Adelaide or anywhere else associated with your employment or through a volunteer organisation, please provide evidence for the Diocesan Trainer, Linda Vinall. She will assess the training completed before you are exempt from the course. Only those who complete this training will be able to continue to hold their position in a Parish or Pastoral District in the Diocese.
