REPORT OF THE FIRST SESSION OF THE SEVENTEENTH TRIENNIAL SYNOD

HELD AT WOODCROFT COLLEGE, MORPHETT VALE ON FRIDAY AND SATURDAY 25th AND 26th MAY 2018

COMMENCEMENT

The Synod assembled at Woodcroft College in the Mark Porter Hall, Morphett Vale at 4.00pm on Friday 25th May.

The President, Archdeacon Peter Carlsson advised that Bishop John had hurriedly returned to England due to the illness of his mother, Ivy, for whom Prayers were said. The President outlined the format of the Synod, indicating that the business session would commence at 5.00pm and be finalised by 6.45pm for the dinner and fellowship adjournment. It was advised that the Chancellor will chair most of the meeting in the absence of the Bishop.

Andrew Forder, on behalf of the incoming Headmaster of Woodcroft College Shannon Warren, welcomed all in attendance, before thanking all in the school community who had prepared the school facilities and the catering arrangements for the members of Synod. Mention was made that the Hall had been renamed The Mark Porter Hall in acknowledgement of Mark Porter, former headmaster, recently retired.

The President presided with 18 clerical and 62 lay members of Synod in attendance.

PRESIDENTIAL ADDRESS

Bishop John delivered his Presidential Address via pre-recorded video during Evening Prayer.

PROCEEDINGS

The Chancellor called over the Notice Paper. Those motions for which no member called "object" were put immediately without debate.

Standing orders were suspended once during this Session to allow for an extension of time until 1.00pm Saturday.

All other business proceeded in accordance to the Notice Paper.

Sessional Orders were generally followed during the sitting.

Dr Ruth Holmes (wife of the Reverend Nathanael Reuss) was the guest speaker at the Synod Dinner. Her theme was "*Tales from the Emergency Department*."

The Reverend John Warner, who worked for many years within the Holy Trinity, Adelaide network of churches, guided teaching and discussion in relation to "Connecting people to Jesus and his Church one by one" as the major item on the Notice Paper to address the ongoing challenge concerning how to grow the Church in the Diocese.

This was well received with thanks being expressed by Mr Rick Fisher.

The Chancellor closed the Session of Synod at 1.06pm on Saturday 26th May.

OBSERVERS

The Chancellor welcomed the observers from both the Diocese of Adelaide and the Diocese of Willochra.

Diocese of Adelaide – Dr Baden Teague is here for the Triennium and provided Greetings from Archbishop Geoffrey Smith on behalf of the Diocese of Adelaide and mentioned some personal associations with the Diocese of The Murray. He noted Mark Porter's contributions as head of Woodcroft College and was pleased that the Hall we were assembled in had been renamed after him.

The Registrar read a letter from the Reverend Canon Simon Bailey - "I am writing to say a very big 'thank you' to you all for your fellowship, hospitality, love and prayers over the years that I have been Observer at your Synod. You have made me feel 'part of the family' and that has been a great privilege. The time has come for me to relinquish some roles in order to focus on other things but I hope that we shall see each other from time to time."

Diocese of Willochra – Mr Tim Butler on behalf of himself and wife Julia mentioned that the previous representatives from Willochra were unable to be in attendance as the Willochra Synod is being held on the same weekend. He was pleased to be amongst a number of familiar faces, he remains in touch with the happenings of the diocese through a relative who is becoming increasing optimistic about what is happening, the renewed growth and the wonderful warm feeling which is happening. Noting that there has been change and there will continue to be change, and this is true in The Murray, Willochra and right across the Anglican Communion. In closing he extended the warmest of warm Greetings from the Willochra Diocese.

QUESTIONS SUBMITTED WITH NOTICE

Relating to the property at St Francis, Christies Beach

- 1. Why, without consultation, were a set of plans provided to the congregation that involved the entire removal of the existing Church and all buildings on the site and suggesting a Meeting area of what the congregation considers to be of inappropriate small size (about that of the Ministry Centre at Morphett Vale)?
- 2. Noting that the above provided plans were formally rejected by the congregation, and alternate plans (retaining the footprint of the existing Church and maintaining provision for housing the community supported Pipe Organ and continuing the essential Op Shop outreach plus providing adequate parking by giving up the Rectory, Op Shop and Rental property and providing significant blocks of land for sale and/or development) have been provided by the Development Committee by the required date, when can a response be expected?
- 3. Are AnglicareSA still involved in the exercise?
- 4. What consideration is/has been given to the potential for severe reputational damage being caused to the Church should the existing, structurally sound and unique Church structure that was supported by significant Diocesan-wide fundraising, be demolished?
- 5. Could Synod be assured that no sale or disposal of any land or buildings associated with the Christies Beach site will occur unless the formal requirements of the Regulation of 2006 regarding the Sale of Properties that appears on the Diocesan website (or any altered Regulation should changes be considered) is entirely complied with, especially regarding the congregational assent to any land sale or change of use that is encompassed therein.
- 6. Could Synod be provided with details comparing the potential financial outcomes of the rejected plans and the congregation's proposed alternatives, taking into account the potential need for some accommodation for a Priest will need to be found and funded.

1. This statement and question is completely incorrect and ignores the process undertaken in relation to the Christies Beach site.

The facts in this case are as follows.

- At the May 2016 Synod I gave a property report that identified the Christies Beach site as a example of a site with "SHORT TERM DEVELOPMENT POTENTIAL"
- Subsequently the Diocese and Anglicare engaged Trice Project Management to look at options for the site.
- In Feb 2017 members of the FAI Committee had an open meeting with the members of the Pastoral District of the Southern Suburbs where we discussed the 12% to the HMF, the IAS and Property in the Southern Suburbs. The redevelopment of Christies was discussed and we agreed that a meeting with the Christies Beach congregation should take place to look at the redevelopment option put forward by Anglicare.
- On the 30th April 2017 Fr Peter Simmons and I attended the Sunday morning service at St Francis and addressed the congregation after that service.
 - I note that the submitter of this question had emailed Fr Peter Simmons a week before the meeting suggesting he "RECONSIDER THE ATTENDANCE AT CHRISTIES BEACH NEXT SUNDAY" the email also states 'THEY ALREADY

KNOW WHAT WAS THOUGHT ABOUT AND PLANS COMPLIMENTS OF THE BISHOP' VISIT.

- The meeting went ahead and we tabled copies of the Anglicare proposal that showed
 - Complete removal of all buildings on the site
 - Subdivision and sale of 8 lots along the O'Halloran Rd boundary
 - Retention of a 1471m2 site by Anglicare for development of community housing
 - Retention of a 470m2 site on the corner of Dyson Rd and Kenney St for development of a new community building for the parish.
- o The meeting identified 4 areas of concern
 - The memorial gardens
 - The organ
 - The Op shop
 - Detail of the new community centre and parking.
- We asked the congregation to look at options for the gardens, organ and Op shop and undertook to get some more detail on the community centre. A copy of the plan was left with one of the congregation members who undertook to make them available for discussion and to keep them confidential.
- o Fr Peter Simmons and I left our contact details so that we could address any issues as they arose. No contact was made with us from that meeting.
- o All of the above was reported to the May 2017 Synod.
- We subsequently engaged EnvironArc to design a community facility. This was at no cost to the Diocese. The draft plans increased the size of the community lot and provided for a 160m2 community centre, 84m2 op shop and some off street parking. EnvironArc had discussed the proposal with the City of Onkaparinga.
- The draft plans were discussed with the Southern Suburbs Clergy team, and members of the Southern Suburbs Pastoral District Council.
- Fr Peter Simmons and I met again with the Christies Beach congregation after the Sunday service on the 10th December 2017. This meeting looked at the draft plans for the community centre.
- The meeting finished with the congregation deciding to form a committee to look at the plans and provide a response by 31 March 2018.
- o In response to a request from Fr Paul following the meeting I forwarded a copy of the latest plan showing an overlay of the existing buildings. In my response I also asked that "any review needs to consider the draft plan put forward by EnvironArc and how they could be modified to suit the current congregation and the community in the future".
- I submit that the proposals for the site have been undertaken without consultation are incorrect.
- 2. A response was sent by Fr Paul Monash on 27 Feb 2018 which among other things stated that the plans were formally rejected. There has been no comment from the Pastoral District Council on the plans we submitted.

The question suggests that an alternate plan is based around retention of the organ and the Op shop and does not address the question of what facilities are needed in the SSPD to support the Church into the future. Those that have seen the EnvironArc plan will note that provision has been made for an upgraded Op shop facility.

While the response of 27 Feb refers to alternate plans, no such plan has been received. No effort has been made to comment on the plans submitted. We are not going to spend time on costing alternate plans when the existing plans have not been addressed

- 3. Yes, Anglicare are still interested in the site on the basis that it provides an opportunity for community housing.
- 4. Any redevelopment of Church land anywhere needs to be handled in a way that promotes the benefits to the community.
- 5. Any land disposal/development is subject to the Diocesan Regulations. Christies Beach is no different. Diocesan Council are the body that will approve of any disposal/development.
- 6. Synod is not the place to discuss these details, Diocesan Council is the forum.

Given that the Constitution sets out the process for calculating the number of lay Synodsmen for each parish and pastoral district as:

2 for the first 100 communicants and 1 for every 100 or part thereof thereafter in the case of parishes - Section 6 (e) and

the Bishop and DC shall determine the number of lay Synodsmen in the case of pastoral districts - Section 6 (g)

- a) Why have some Mission Districts been allocated 8 lay Synodsmen for only 2 pastoral districts (e.g. Murraylands, Lower Limestone Coast) whereas others which comprise up to 4 pastoral districts (e.g. Southern Suburbs) have also been allocated only 8 lay Synodsmen and in the case of the only Mission District with fully functioning parishes (The Hills), the allocation is 7 lay Synodsmen for 2 parishes and one pastoral district?
- b) If the allocation in Murraylands and Lower Limestone Coast is based on the number of communicants then why have their pastoral districts been classed as pastoral districts at all because if they have in excess of 100 communicants then they are presumably perfectly able to be an "effective functioning unit of the Church in worship, service and extra parochial responsibility"- Sec 21A of the Constitution?
- c) If the allocation is not based on the number of communicants, on what was it based?

a) Diocesan Council are working on a plan which has an equal fixed number of representatives per Mission Partnership getting away from the formula which has been used in the past. It

looked at the then composition from each of those partnerships in the last Synod and ensured that none would be worse off.

So, Diocesan Council decided for those Pastoral Districts known as Mission Partnerships that they could elect up to 8.

- b) All Mission Partnerships (apart from the Hills and Upper Limestone Coast) are officially one Pastoral District each, Southern Suburbs has been one since 2014 and in fact has doubled its representation from the last Synod and has less Churches than the Murraylands.
- c) The Murraylands Parish asked to be made into a Pastoral District along with Port Elliot-Goolwa and Mount Gambier in order to progress the plans.

There are two proposed Mission Partnerships where it was not possible or practical to form at this stage so the status quo remained for those areas.

Until all areas are running under one structure there will always be anomalies.

The answers to these questions were provided in writing to be collected by Members of Synod. No discussion occurred.

QUESTIONS SUBMITTED WITHOUT NOTICE

In the Financial Statements under the heading Building Feasibility Costs 2016 \$90,954 and 2017 \$4,690 - which account/s did this money come from and what is now the state of play of the \$7m Cathedral?

As stated at Synod, the money came from general revenue which was reported last year in the diocesan accounts, the state of play of the Cathedral is that the Cathedral development which consists of two buildings – a commercial building and a Cathedral, there is a development approval which is current until Mar-Apr 2019. At that time we can make the decision to apply to extend the development approval which sits with the land. Synod were advised yesterday that the diocese has been talking with accare about a joint venture with the commercial building, however that joint venture is not going ahead and the diocese has been talking with one other party who has indicated that they may be able to respond by the end of May 2018. If this does not happen the diocese could look for additional joint venture partners. It was always intended that the first stage of that development would be the commercial building out of which we could release some funds to build a Cathedral because as you are all aware there are no funds currently available to construct a Cathedral.

I believe the Bishop went back to the UK six times – three times last year and three times this year. What reimbursement if any has been received from the diocese for these trips?

It is a matter of record that the bishop has returned to the UK once a year funded as per his agreed package. In addition the Diocesan Council, as a generous gift, paid for two additional airfares to

enable Bishop John and Bridget to return after one of their sons suffered additional trauma following the death of a child. Other trips the bishop undertakes have been and remain at his own expense.

REGISTRATION OF MARRIAGES

ABOLISH THE PUBLIC HOLIDAYS ASSOCIATED WITH CHRISTIAN FAITH
